Agenda Item No.4

Activity Report by the Secretary General of ECOSAI

The Secretary General ECOSAI presented the Activity Report for the year 2019-20 & 2020-21 for 25th ECOSAI Governing Board Meeting December 2021.

- The Auditor General of Pakistan mentioned that many activities approved during 24th ECOSAI Governing Board Meeting but could not organize according to schedule due to COVID-19.
- ii. The Accounts Committee for Control over Execution of the Republican Budget for the Republic of Kazakhstan organized ECOSAI E-Seminar on "Audit of Sustainable Development Goals" on June 9, 2020. This first E-Seminar encouraged member SAIs to move from face to face training to online training.
- After successful hosting of this seminar by the SAI Kazakhstan, the SAI Pakistan also hosted two days online training course on "Risk Based Auditing" from27January 2021.
- iv. The Accounts Committee for Control over Execution of the Republican Budget for the Republic of Kazakhstan organized ECOSAI Seminar on "Audit of Public Debt" on 25th November, 2021 through video-meeting.
- v. The ECOSAI Secretariat prepared and designed four issues of ECOSAI Circular since the last ECOSAI Governing Board meeting was held, digital copies of the circular were disseminated among the member SAIs.

- Articles on different topics including impact of COVID-19, SDGs, quality framework, forensic audit and disruptive technologies were covered in these Circulars.

Mr. Owais Ahmed, Deputy Director, Office of Auditor General of Pakistan presented the Annual Accounts of ECOSAI for the year ended 31 December 2019 and 31 December 2020. He explained in details the following:

Mr. Vugar Gulmammadov, Chairman, Chamber of Accounts, Azerbaijan, inquired about the impact of COVID 19 situation on annual subscriptions of ECOSAI members. It was

briefed that 4,920 USD were deposited in FY 2020 in annual contributions by ECOSAI members as compared to USD 9322.88 USD in FY 2019. It is evident that COVID 19 situation had an impact on cash inflows. However, the inflows are expected to gain their usual momentum in the closing months of FY 2021 and would match the inflows of FY 2019. The Chairman, Chamber of Accounts, Azerbaijan inquired about the provisions of expenses from the ECOSAI funds. He was briefed that the funds are specially provisioned for harnessing mutual cooperation and enhancing capacity of ECOSAI members. Moreover, funds can also now be utilized on the training expenses of members of ECOSAI on request. Currently all the training activities were conducted online. In future, the funds would be utilized against face to face meetings too. The Accounts of ECOSAI are placed at Annexure-VI.

Outcome

GB unanimously adopted the two-year annuals accounts for the year ended 31 December 2019 and 31 December 2020.

Agenda Item No.6

Report of the 20th ECOSAI Training Committee Meeting

Mr. Owais Ahmed, Deputy Director, Auditor-General office of Pakistan, presented the outcome of 20th TCM in 25th GBM. Mr. Vugar Gulmammadov, Chairman, Azerbaijan Chamber of Accounts inquired about the future strategy of ECOSAI in context of online training courses. He was briefed that ECOSAI has modified its approach and adopted online trainings as a mean to continue with interaction among ECOSAI members. He was briefed that the members of 20th TCM have realized to change the approach and design of training courses. The courses would be launched on Online Learning hubs as self-paced Massive Open Online Sessions (MOOS). The Secretary General ECOSAI,

Auditor General of Pakistan would present the feasibility of online learning hub, innovation hub and special audit unit as per the decision of 20thTCM. The development of online learning hub would be the way forward since the MOOC would be available for ECOSAI members in their official languages. SAI Kazakhstan has resolved to offer three courses for the instant purpose.

Mr. Yucel Turhan, Vice President of Turkey Court of Accounts, praised the efforts of 20th TCM and explained that ECOSAI needs to change its methodology. The ECOSAI forum needs to present a new approach and attract the imagination of dormant members. He mentioned that there is a dire need to make the ECOSAI website more interactive. The ECOSAI Website needs to keep track of the visitors and present the news-feed.

The Secretary General ECOSAI, Auditor General of Pakistan, Mr Ajmal Gondal reiterated the resolve and commitment of SAI Pakistan to make the forum more cooperative and significant in the light of recommendations of 20th TCM. The 20th TCM report is placed at Annexure-VII.

Outcome

GB unanimously adopted the 20th TCM report.

Agenda Item No.7

Report on Publication of ECOSAI Circulars.

Mr. Owais Ahmed, Deputy Director SAI Pakistan, presented the Report on the publication of the ECOSAI Circular by the SAI Pakistan. He explained that the ECOSAI Circular is the official organ of ECOSAI and has the objective of providing member SAIs with the forum for sharing experiences in different areas of public sector auditing. Report on MoUs Signed Between ECOSAI Members

Mr. Owais Ahmed, Deputy Director, SAI Pakistan presented the report on MoUs signed between ECOSAI members.

- i. Mr. Owais Ahmed briefed that in pursuance of the 14th training committee meeting of 2014 recommendations, SAI Pakistan has signed MoUs with SAIs of Iran (2016), Turkey (2016) and Tajikistan (2018). SAI Iran has similar MoUs with SAIs of Turkey and Tajikistan. SAI Kazakhstan has signed MoU with SAI of Iran.
- ii. The SAI Pakistan's three-member trainer's team visited Ankara May 07-12, 2018 for delivery of Peer Review training and two members SAI Turkey's delegation visited SAI Pakistan for signing of concept agreement signing as the second phase from August 14-18, 2018. SAI Pakistan's three-member trainer's team visited Ankara December 02-15, 2018 for conducting the Peer Review of TCA and its field work. Peer review report was approved and presented to President TCA electronically on September 16, 2020, which was later on acknowledged by President TCA on September 22, 2020.
- iii. Mr. Owais Ahmed briefed that the SAI Tajikistan has informed that MoU between SAIs Turkey and Tajikistan is almost finalized and just signing-process is awaited.
- iv. It is also informed that signing of MoUs between SAIs of Azerbaijan, Turkey and Pakistan is under process.
